Thank you for expressing interest in being a partner for Jebsen & Jessen's corporate social responsibility activities: Meet a Need.

The History of Meet a Need:

Since 2007, we've empowered our regional staff through biannual corporate volunteering trips. Partnering with charitable organisations like World Vision International, WWF and WCS, we create hands-on opportunities that address real community needs, both social and environmental. Each year, we focus on one of our six regional countries—Indonesia, Malaysia, Philippines, Singapore, Thailand, or Vietnam—and collaborate with a local charity.

A Collaborative Partnership

We seek a passionate partner to co-create a valuable volunteering experience for our staff and ensure our funds contribute to sustainable environmental work with lasting community impact.

The funds

We offer a one-off fund of 100,000 SGD. Trip expenses (staff travel, meals, lodging, etc.) will be deducted, leaving the remaining balance for your organization to continue the project we co-develop. Typically, trip costs range from 10-25% of the fund.

Release of funds

- 10% of the total fund upon confirmation of project. This amount shall be refundable if Jebsen & Jessen Group decides against proceeding with the project.
- 80% of the total fund, minus expenses of the trip, after the successful delivery of the trip.
- 10% of the total fund after first follow-up report, showcasing how the monies have been used.





What we are looking for

With 26 trips over ten years, we know what resonates with our staff: hands-on engagement in meaningful tasks that lead to tangible outcomes. We aim to leave each trip saying, "We helped build that!"

As an organisation with a 60-year regional history, we prioritise sustainable impact and expect partners to demonstrate the lasting benefit of our funding and build upon our collaborative efforts.

We need a partner who can organise a five-day residential volunteering trip:

- meets an environmental need in environmental or Social need in ASEAN,
- lasts five days and takes place in either in May or August 2025,
- provides volunteering activities for a minimum of 15-20 people,
- featuring hands-on, practical activities with visible outcomes,
- Includes accommodation and local transportation arrangements.
